**Rental Information**



<b>Pavilions</b>	April - October. Electricity, grills, restrooms, and nearby playgrounds. Per person entrance fees apply in addition to rental cost. *See below for details.	
<b>Blue Jay -</b>	200-person capacity. 4 large grills ~ 25 five-foot tables; Parking for 50 cars.	~\$200/day
<b>Nuthatch -</b>	200-person capacity. 4 large grills ~28 eight-foot tables; Parking for 50 cars.	~\$200/day
<b>Buck -</b>	150-person capacity. 3 large grills ~17 eight-foot tables; Parking for 36 cars, disabled accessible, near lake, closest to parking lot.	~\$150/day
<b>Doe -</b>	150-person capacity. 3 large grills ~20 eight-foot tables; Parking for 36 cars, disabled accessible, near lake, more secluded.	~\$150/day
<b>Fawn -</b>	50-person capacity. 3 small grills ~2 six-foot tables & ~4 11-foot tables. Parking for 10 cars, disabled accessible, near lake.	~\$50/day
<b>Bobwhite -</b>	50-person capacity. ~4 eleven-foot tables & 4 six-foot tables; Parking for 10 cars, disabled accessible, near lake and open field.	~\$50/day
<b>Cardinal Area Picnic Grove</b>	May - September. An open field, 4 grills, picnic tables & restroom. 100-person capacity with parking for 35 cars.	~\$50/day

**Cancellation Policy**

- Call 1-888-432-CAMP (2267) M-F 9-5pm.
- 30 days or more prior to the scheduled arrival date there will be a \$4.75 cancellation service charge.
- Cancellations made 8 to 29 days prior to the scheduled arrival date will be a charged 50% of the reservation cost.
- *No refunds will be issued for cancellations made within 7 days or less of the rental date.*

**Alcohol Policy**

- Alcohol permits are a \$35 add-on, issued when you make a reservation.
- Alcohol must remain in the rented space. A permit may be revoked for cause by a park employee.

**Trash Policy:** *If you bring it in, you pack it out with you. The park has no trash receptacles. Renters are responsible for bringing trash bags & cans then must remove all the trash they generated from the park.*

**\*Service Charges:**

**Weekends & Holidays April - October** Maryland residents - \$3/ person.  
Out-of-state residents - \$5/ person.

**November through March:** No service charge.

*Service charges are waived for children in car seats, Maryland Golden Age Passholders, Veterans & Active Military*

**Admission Tickets:** \$3.00 / Maryland or \$5.00 / Out of State Residents. Purchase tickets in advance from the park office 301-924-2127 to schedule pickup. Limited to the capacity of the rental space. Should be distributed to your guests prior to the event date. **NO REFUNDS.**

## General Park Rules:

- Leashed pets are allowed except on the tire playground, boat center, or on rental boats
- **No amplified music**
- Park in designated spaces only
- Hand launching permitted in Clopper Lake- No gas engines
- No Water balloons, pools, dunk tanks, petting zoos or pony rides
- No Moon bounces or generators
- Grills are for charcoal only, not wood; bring your own charcoal
- Small signs may be placed on stakes in the ground (not on park signs)
- Decorations may be tied with string--*no nails, staples, or tape on tables or pavilions*
- Please remove all signs and decorations at the end of your event
