**CERTIFICATION OF FAMILY TRANSFER**

Pursuant to §8-716 of the State Boat Act, a vessel transfer between immediate family members is exempt from vessel excise tax so long as the vessel is registered in the State of Maryland and the transferor(s) previously paid Maryland vessel excise tax on the transferred vessel.

This form must be submitted along with a properly assigned Maryland Certificate of Title. All transfers require payment of a title fee. If vessel is over 16 feet in length or propelled by a motor greater than 7.5 horsepower, a registration fee is also required.

**Definition of "Members of the Immediate Family"**

In determining which persons are exempt from the title tax provided by Natural Resources Article, §8-716, the term "members of the immediate family" includes the following persons: spouse, son, daughter, mother, father, sister, brother, grandmother, grandfather, son-in-law, father-in-law, mother-in-law, daughter-in-law, grandson, granddaughter, stepfather, stepmother, halfbrother, halfsister, stepson, or stepdaughter. The term includes persons so related by virtue of adoption.
