**** NEW NON-DISCLOSURE OF PERSONAL RECORDS INFORMATION:

The Department will not disclose a personal record unless permission has been granted by the individual except for use in carrying out its governmental functions or unless otherwise provided by law,

COMAR 08.01.06 (G) Reads as follows:

Except for use in carrying out its governmental functions, the custodian shall not disclose, and shall deny inspection or copying of, any part of a public record that contains sociological information relating to an individual. For purpose of this section, sociological information means:

1. Social Security number;
2. Personal address;
3. Personal telephone number;
4. Personal e-mail address;
5. Medical history;
6. Educational history;
7. Work history;
8. Military service;
9. Financial information;
10. Religious preference, membership, and attendance;
11. Personal relationships; beliefs and values;
12. Genealogical charts; and
13. Family history.
